

Addendum Statement**

The Addendum Statement should be used for explanation of any additional information needed to complete an accurate form of this report.

Due to an accounting error made by the Campaign Treasurer, the amount of contributions of less than \$100 was overstated on previous reports. After a careful review of all contributions received and expenditures made, it is believed that the error was a result of double counting some contributions under \$100 which resulted in an inflated amount of contributions received under \$100. This reduces that total amount of campaign contributions to \$85,375.30. There appears to be no accounting errors for the expenditures made. As a result, the total amount of cash on hand is \$9,181.08 and not \$10,366.30.
